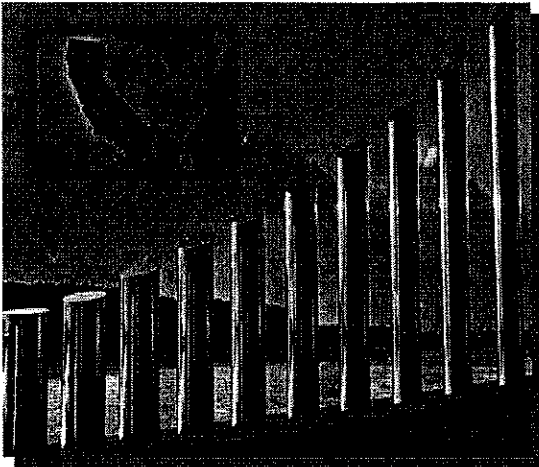


California's "No Lead" Law Product Show and Conference

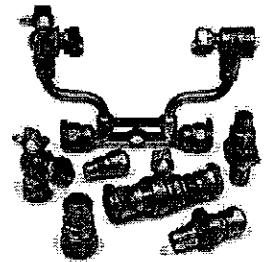
The January 1, 2010 deadline is approaching!

BACKGROUND...

In 2006, Governor Schwarzenegger signed **Assembly Bill (AB) 1953** into law. This law states that on January 1, 2010, no one in California can sell or install a product that touches drinking water if it has more than 0.25% lead. The law has no sell-through period after January 1, 2010, includes products on both sides of the water meter, and has limited exemptions.

In 2008, the Governor also signed **Senate Bills (SB) 1334 and 1395** into law. These laws outline product certification, and provide additional enforcement for AB 1953.

Plumbers, contractors, cities, water utilities, stores, brokers, and others are impacted by California's "no-lead" laws and should attend this conference and product show.



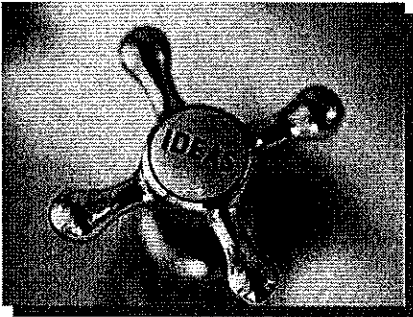

Enforcement on the statewide level should also be on the radar of companies involved with California's "no lead" law.



- What is the state looking for in certification? State law, under SB 1334, requires 3rd party certification. While there are many options from labs, what does your product need to satisfy AB 1953?

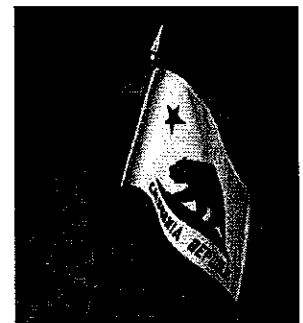
