TERMS AND CONDITIONS

Payment Terms: Unless stated differently on your HIRSCH PIPE & SUPPLY CO., INC. invoice the normal payment terms to charge customers are 1% 10th Prox Net 25th. There will be a 1% discount allowed only when payment is received by the 10th of each month following the date of purchase. 1% discounts taken after the 10th of each month will be "unallowed discounts" and will be charged back to the customers account. All accounts not paid by the 25th of the month following the date of invoice shall be subject to a service charge of 1.5% levied against all past due invoices.

Approval, Revocation of Credit: Credit sales are expressly conditioned upon approval by an authorized officer of Seller. Seller may revoke credit and insist upon payment prior to shipment of any remaining goods at any time for any reason or for no reason.

Delivery of Goods: HIRSCH PIPE & SUPPLY CO., INC. has its own fleet of trucks for deliveries within its marketing area. Material is subject to shipment in whole or in part at our option. HIRSCH PIPE & SUPPLY CO., INC. responsibility ceases upon delivery of material in good order to the customer's receiving point.

Claims: If goods received are visibly damaged upon delivery the damage should be called to the driver's attention and a notation signed by the driver should be made on the packing slip or delivery document. All material should be opened and inspected for concealed damage at time of delivery. Any shortages must be noted as stated above and absolutely no allowances for shortages not reported at time of delivery.

Credit for Returned Goods: Goods must not be returned without our written consent. Materials returned because of errors made by manufacturers to HIRSCH PIPE & SUPPLY CO., INC. will be credited at the invoice price. If the cause lies with the customer, we will attempt to minimize his expense or loss; but we reserve the right to make reasonable charges for handling of returned merchandise, including transportation costs. Returned goods must be in first class salable condition and of current model. Materials returned for credit after 45 days from the date of authorization by HIRSCH PIPE & SUPPLY CO., INC. will be voided.

Pricing: All prices are subject to (i) change without notice to you, and (ii) immediate acceptance by you.

This authorization is for any inquiry without respect to those reported by the applicant. Your signature also assures indemnity to any person who replies to said inquiries.
